## Introduction

The fifth Annual Report of the Fulbright New Zealand Alumni Association Inc highlights the achievements and continued progress made during the 2013 - 2014 year. Key developments highlighted in the report are:

- Following the move to zero fees. There are now 2143 alumni association members globally.
- arranging 15 alumni events and facilitating invitations to a number of events arranged by other organisations;
- providing opportunities for 12 alumni to share their thinking in forums with the public and/or professional communities of interest;
- increasing interaction between alumni and current grantees through the expansion of the home stay programme that provided 52 “bed nights” and additional welcome dinners for incoming US grantees;
- continuing the support for the alumna-initiated programme *Fulbright Reflections* and expanding it to be held in three regions, Wellington, Otago/Southland and Auckland;
- nominating alumni for national and regional awards where appropriate.

The Association continues to benefit from the services of a part-time alumni coordinator (five hours per week on average) based at the office of Fulbright New Zealand.

The Association continues to face challenges in becoming self-sustainable and continues to rely on grant funding from the US Department of State and support from Fulbright New Zealand.

In summary, the Association has continued to sustain opportunities for alumni to “give back” what they have gained from their Fulbright and associated exchange programmes.

## Chairperson's Report

How fortunate we are to be surrounded by such inspiring and dedicated ambassadors of New Zealand.

It gives me great pleasure to present the fifth annual report of the Fulbright New Zealand Alumni Association. We have had yet another year of exciting exchanges with our American counterparts and I remain grateful to be continuing my own journey with Fulbright New Zealand having completed my scholarship in 2007 and now working with the Association to facilitate support for incoming grantees and the opportunity to give back for the accomplished individuals who transition from grantee to alumni each year.

The vote to reduce Alumni Association membership fees to zero at last year's AGM has meant that we can now attest to having over 2000 members globally, just under half of these alumni are based in New Zealand.

The homestay programme is a highlight of our annual calendar both for the incoming grantees and the opportunity it provides for alumni to engage with likeminded grantees and also give back to the programme. A total of 52 bed nights were allocated this year along with additional airport greeting and family dinners for grantees not requiring a homestay.

The fixed term contract for the paid Alumni coordinator role was renewed this year and we are grateful to Fulbright New Zealand for their generous grant funding to enable this position. Next year Fulbright New Zealand and Fulbright New Zealand Alumni Association have agreed to incorporate the alumni coordinator role with the events coordinator role within Fulbright New Zealand. Vicky Beckett now works 20 hours at Fulbright New Zealand providing alumni with a seamless service across both organisations.

Fulbright Reflections and Fulbright lectures continued this year using the remaining funds from a US Embassy grant received last year. This grant also enabled us to provide a Thought Leaders Forum entitled building an alumni culture in New Zealand. Alumni from the regions gathered at Fulbright New Zealand for an information sharing morning which included external alumni experts sharing their knowledge of alumni relations in New Zealand. During the afternoon the Board used the information gathered to relook at the strategic activity for the coming year. This was broken down into a one page plan which included five key areas of governance, resources, volunteers, communications and activities. In the coming year Board members will be allocated specific areas to focus on.

As a reminder, the Fulbright New Zealand Alumni Association continues to provide opportunity for

We have much room for improvement with regards to our governance, communication and activities. Volunteers are key to the success of the organisation. Over the coming year we will be inspiring alumni to give back in the most effective way for them and the organisation as a whole. We were lucky enough to hear from an expert in volunteering during our thought leaders forum. She explained the model of volunteering to participants and with that described that there should always be opportunity for volunteers to engage, step aside and then re-engage depending on their own situation. This resonated with all of us.

The Association continues to enjoy strong support for Mele Wendt, Andy Mitchell and the team at Fulbright New Zealand, including the Board. Phil McKenna at the US Embassy should also be noted for his support, particularly in helping us to secure appropriate grant funding. We will all be very sad to see Mele leave her role as Executive Director of Fulbright New Zealand early in 2015 but we wish her well for her next adventure and hope to see her back attending our events in the future. Special thanks also go to Graham Cochrane our immediate past chairperson. His on going support is very much appreciated.

My two year term as Chair will be completed by the time of the AGM in August. I have decided to step aside to allow new energy to the role but hope to remain on the Executive. I would like to thank everyone involved for supporting me on what has been a thoroughly enjoyable learning experience.

The Board met in Wellington on 14 August 2013 and by teleconference on 19 February 2014, 28 April 2014 and again in person on 27 June 2014.

The Board has provided a coordinated approach to developing policies as well as building a programme of events across the country.

### Executive

An executive committee comprising the chairperson, secretary and treasurer has the role of administering and managing the Association between board meetings, and providing support for the regional coordinators.

The Executive Committee met in Wellington on 17 July 2013, 23 October 2013, 13 December 2013 and 27 March 2014.

### **Alumni Coordinator**

Vicky Beckett continued the role of Alumni Coordinator through 2013/2014. Her contract position was changed to be managed through the association itself rather than Fulbright New Zealand for approximately 5 hours a week (a reduction from 12 hours per week in the previous year). Her position is funded by Fulbright New Zealand. The Association is very grateful to Fulbright New Zealand for their support.

The role of coordinator is vital to the smooth operation and coordination of the Association's activities and the Association is grateful to Vicky for her efficient and professional services.

## Membership

At the 2013 AGM a motion was carried that ‘approval be given for the Board’s decision to set the annual subscription for full membership at zero.’ Approval of this motion allowed the Association to include all alumni as members and to engage with a wider number of alumni.

Generous grants from Fulbright New Zealand and the US Department of State make free subscription possible.

## **Building an Active Alumni Network**

The Association is organised into six New Zealand regions (Auckland, Waikato, Central North Island, Wellington, Canterbury and Otago-Southland) and two US regions (Midwest and New England).

Each region has a coordinator supported by deputies or coordination groups to arrange alumni activities and networking in their regions. The coordinators and their teams are the drivers of activities in their regions and the Association has been fortunate to have the voluntary services of an outstanding group of people in some regions, who have shown commitment and creativity in their role.

During 2013, due to lack of volunteers the Waikato and Central North Island regions were unrepresented.

### **Home stay Programme**

For the fifth consecutive year the FNZAA worked in partnership with Fulbright New Zealand to extend the welcome to incoming US Fulbright grantees by offering alumni home stays in January/February. All incoming grantees were offered home stays with alumni on arrival in New Zealand and also for one night as part of their orientation programme. For the second year incoming grantees not requiring an overnight stay were also offered dinner with alumni and their families. As a result, the Association was able to arrange 52 bed nights (including some airport greetings) on arrival for grantees and an additional six dinners for alumni and their families on one evening, in Wellington, during orientation week.

The FNZAA is very grateful to all alumni who provided accommodation and hospitality and made this programme so successful.

### **Alumni activities**

The Association continues to encourage alumni to initiate their own projects and activities with support from a US Department of State grant.

**Fulbright Reflections** were again held in Wellington where a total of nine alumni presented at 3 separate events. The programme was also extended to Auckland and Dunedin this year. The Auckland event was held in partnership with the Wallace Arts Trust and with The Otago Meseum in Dunedin.

### **Fulbright Lecture series**

Arrangements commenced for the 2013/2014 Fulbright Lecture series which will see Sir Tamati Reedy visit the main University Centres during the second half of 2014.

### **Activities**

Through the hard work of the coordination teams there were 15 events involving members, alumni and the public throughout the country between 1 July 2012 and 30 June 2013. In addition, invitations were received to a number of other lectures and receptions arranged by other organisations including Fulbright New Zealand.

Each region continues to develop its own preferences for events that meet the needs and interests of their members. Activities have increasingly involved alumni displaying thought leadership in public arenas.

### **Thought Leaders**

Further funding from the US Embassy enabled the Association to hold a Thought Leaders Forum in Wellington during late June. The facilitated event was entitled 'Building an alumni culture in New Zealand' and formed a useful background discussion to a strategic planning session for the Association Board. Four external contributors gave insights into their own perspectives and experiences in Alumni Relations in New Zealand. The findings from the external and internal sessions will contribute to the strategic plan for coming years.

### **Projects**

During August 2013 Clemency Montelle, Canterbury regional coordinator worked with the US Embassy to document interviews with local Fulbright alumni. The interviews can be viewed on Youtube at <https://www.youtube.com/watch?v=KYDQ05Osb84>

### **National**

Gala dinners and art auctions, organised by Fulbright New Zealand were held during September 2013 in Wellington and Auckland. The events were targeted at a primarily alumni based audience.

The last annual meeting was held in Wellington on 8 November 2013.

All alumni based in the Wellington region were invited to the Fulbright New Zealand Annual Awards Ceremony and Alumni Reception at the Beehive, Parliament on 24 June 2014, this was arranged by Fulbright New Zealand.

## Financial Report

The Association has completed its fifth financial year in a sound financial position. The Association has cash funds at 30 June 2013 of \$24,230, with current liabilities of \$7,470 relating to unexpended conditional grants, an audit fee and expenses related to the Thought Leaders Forum. The remaining cash available for use comes from multi-year membership subscriptions and operating surpluses from past financial years.

Expenditure on alumni projects decreased to \$9,292 in 2013/14, down from \$13,728 in 2012/13, but still significantly higher than in earlier years. The alumni projects reflect the events and activities organised by the Association's regional coordinators. The decline in expenditure here reflects a reduced number of events taking place, particularly in certain regions.

The costs of administration coordination have reduced substantially from \$19,509 in 2012/13 to \$9,691 in 2013/14 because we have engaged the administrator for fewer hours. However, the Association has been fortunate to receive excellent support and value from the work of our Alumni Coordinator, Vicky Beckett.

This year the Association implemented the move away from charging membership subscriptions to refocus the efforts of the Alumni Coordinator toward raising grant revenue and support events. This has contributed to our lower administration costs. Funding from Fulbright New Zealand and grant funding from the US State Department has enabled the Association to continue its operations without materially affecting performance or the balance sheet, which is showing a net surplus of \$2,918 as at 30 June 2014. While the Association should continue to pursue these sources of funding in future, there is no guarantee that it will continue. As such, it would be worthwhile for the Association to investigate supplementary and alternative funding sources in the coming year.

# Fulbright New Zealand Alumni Association Incorporated

## Notes to the Financial Statements

### 1) Reporting entity

Fulbright New Zealand Alumni Association Incorporated is the reporting entity. It was incorporated on 19 October 2009.

The principal activity of the Association is to celebrate and promote international educational exchange by connecting Fulbright and associated international exchange alumni with each other; supporting the mission of Fulbright NZ and current grantees; and raising awareness of the aims of the Fulbright programme.

The financial statements cover the period 1 July 2013 to 30 June 2014. They were authorized for issue by the executive on 21 July 2014.

### 2) Basis of preparation

#### *Statement of compliance and basis of preparation*

The financial statements have been prepared in accordance with NZ GAAP. They comply with NZ equivalents to NZ IFRS and other applicable Financial Reporting Standards, as appropriate for public benefit entities that qualify for and apply differential reporting concessions. The Association qualifies for differential reporting exemptions as it has no public accountability and it is small in terms of the size criteria specified in the Framework for Differential Reporting. All available reporting exemptions have been adopted.

#### *Basis of Measurement*

The financial statements have been prepared on the historical cost basis.

#### *Presentation Currency*

The financial statements are presented in NZ dollars.

### 3) Significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

#### *Trade and other receivables*

Trade and other receivables are measured at their cost less impairment losses.

#### *Trade and other payables*

Trade and other payables are stated at cost.

### *Revenue*

The Association's activities are supported by grants, members' subscriptions, donations and interest from bank deposits. Grants received that are subject to conditions are initially recognised as a liability and revenue is recognised only when the services are performed or conditions are fulfilled. Subscriptions from members are recognised as income when received. This year the Association moved to a zero member subscription regime.

### *Taxation*

The Association is not GST registered. It is liable for income taxation.

### *Changes in Accounting Policies*

There have been no changes in accounting policies during the year.

### **5) Related parties**

Mele Wendt, Executive Director of the NZ US Educational Foundation, and David Edginton, board member of the NZ US Educational Foundation, are both ex-officio members of the Fulbright NZ Alumni Association's board. The NZ US Educational Foundation is supporting the Alumni Association by providing up to \$10,000 per annum for the Association's Alumni Coordinator. This financial year the NZ US Educational Foundation provided \$10,000 (2013: \$12,909).

### **6) Income taxation**

On 6 December 2014 the Association was advised by Inland Revenue that it qualifies for an income tax deduction because it is a non-profit organisation. If net income after expenses is less than \$1,000 the Association not required to file an income tax return. It has not provided for income taxation this year.

### **7) Conditional grant**

In April 2013 a conditional grant of \$14,263 was received from the US Embassy for three projects; Thought Leaders, Fulbright Reflections and Fulbright Lectures. After a grant extension this grant was to be used by 30 June 2014. FNZAA is currently negotiating with the US Embassy for a further extension. If it is unsuccessful the unused grant is required to be refunded to the US Embassy.

**8) Other**

The Association has no operating lease commitments, no capital commitments, and no contingent liabilities at balance date (2013: nil). There have been no material events subsequent to balance date that would result in adjustment to or disclosure in these financial statements.
